Low Cost Disposal of Recovered Refrigerant

* Cylinders will be exchanged at R & E Supply locations on an as needed basis with the following fees:

AIRG-HANDLING CHARGE	Handling and processing fee on all cylinders.	\$20.00
AIRG-CLEANOUT FEE	Fee for cleaning out any cylinders returned empty.	\$60.00

* Your cylinder will be tagged with a numbered tag, you will receive a yellow copy of that tag and the tag number will be recorded on the sales order.

* You will be given an evacuated certified cylinder in direct exchange for a full cylinder.

*** Effective September 2018**

A credit of **\$2.25** per lb will be credited to your account if the R-22 tested is deemed to be at least 99% pure.

It will be credited as follows:

AIRG-REFR R22 PURE RECOVERED PURE R22

Credit takes 4-6 weeks to post on your account.

Refrigerant weight to be determined by reclaim company.

* All empty exchange cylinders will be provided to you evacuated within retest/recertified date code, non leaking valves, and good usable handles.

* All gas returned that does not meet purity standards will be treated as mixed gas. This includes all blends and will be billed to you as follows:

AIRG-USED REFR MIXED Disposal of Mixed Gas and Blends **NoCharge**

* **Effective July 1, 2009**, refrigerant will only be excepted from companies who agree in writing to this program. *(see below agreement)
